## 2. Subjects Discussed:

- A) Overall project scopes were provided by Leo Green III, PE Base Bid is a Typical Streetscape Project with
  - i. 700 SY Remove and Replace Concrete Sidewalk
  - ii. 610 LF Remove and reset existing granite curb.
  - iii. 250 SY Remove and Replace Asphalt (2" 9.5B & 5" B25.0C)
  - 200 LF Decorative Aluminum Hand Railing at step on (southside sidewalk)
  - v. Adjust decorative light poles to new grades.
  - vi. New electrical system controls landscape lighting receptables
  - vii. Meter Box Adjustments water service adjustments
  - viii. Handicap ramps with truncated domes to meet ADA requirements.
  - ix. Engravable pavers Town has approximately (70) seventy red pavers sold to be installed by the Contractor in the designated area–The town will turn over engraved pavers to awarded contractors.
- B) Alternate Bid is an upscaled decorative version of base bid with:
  - i. Stamped Asphalt Crosswalk

- ii. Stamped Concrete Sidewalk
- iii. Street Bulb Outs and Landscaping Islands
- iv. New electrical system controls landscape lighting receptables
- v. Similar Items from Base Bid
- 3. Pre-bid meeting is **non-mandatory** to participate in bid. If you decide **not** to bid the project -please contact **Chris Ray/Leo Green III** with Green Engineering @ <a href="mailto:c.ray@greeneng.com">c.ray@greeneng.com</a> and <a href="mailto:elg3@greeneng.com">elg3@greeneng.com</a>. Penny Glover with Green will be reaching out to bidders as reminders the day before bids are due as a friendly reminder.
- 4. Make sure to read instructions to bidders and fully execute the contract Failure to execute bid form could result in disqualify of the bidder we do not want that to happen. Five percent (5%) Bid Bond is required with the bid.
- 5. Performance and Payment Bonds are required of the awarded bidder.
- 6. All questions shall be directed to *Chris Ray/Leo Green III* plus shall be in writing to c.ray@greeneng.com and elg3@greeneng.com
- 7. Questions will be accepted until: *Tuesday, March* 17<sup>th</sup> by 2:00 pm with final addendum will be issued no later than Wednesday,18<sup>th</sup> 2025 by 2:00 pm.
- 8. Sealed Bids must be received by 2:00 pm on March 25th at Weldon Town Hall -109 Washington Ave.
  - a. Use provided bid proposal forms bid good for 120 days.
  - b. Use provided bid bond forms.
  - c. MBE Requirements documents
- All Contractors and Subcontractors must be NCDOT Prequalified and license general contractor per NCGS 87.1. as Washington Street is NCDOT maintained (SR1651)
- 10. Project Duration 120 days from NTP. The project is projected to start in June 2025.
- 11. Liquidated damages are \$500 per day for substantial completion and \$500 per day until final completion.
- 12. Sales Tax Reporting will be required of the successful bidder with each application.
- 13. One year warranty on all work is due upon completion.
- 14. Any geotechnical testing if required will be provided (provided at the owner's expense)
- 15. Construction engineering inspection will be provided by the Green Engineering inspections team led by *Rupert Welfare*.
- 16. Contractors will be required to clean-up the work area and remove debris daily. During Construction, if the contractor discovers an environmental issue, the contractor is to notify the Engineer and Town immediately. The Town/Engineer will consult and provide directions to the contractor.
- 17. A site visit/walk through was declined by the two contractors.


